# INTRODUCTION



Another successful year at AOC has ended, and we are preparing to celebrate 60 years in 2024. The association has unveiled a new tagline to kick off the celebration: "Join the Legacy, Shape the Future," which summarizes our dedication to moving the organization into the future while honoring our history.

2023 was spent evaluating AOC's membership structure and education program. Working with McKinley Advisors, we determined we needed to raise our annual dues and transition to a new membership model, which included introducing a new Partner Program that better serves our corporate interests. Other changes will bring more value to our members while incentivizing AOC education and training courses.

The organization has invested in human resources over the past few years, and our staff is now 18 people strong. In 2023, we hired a full-time Director of Strategic Partnerships and Training and a consultant serving as our Senior Technical Advisor. These additional staff members are instrumental in executing our five-year strategic plan.

We continue to hold steady with a membership of approximately 14,600 EW and EMSO professionals. Individual dues increased on January 1, 2024, and partner rates increased in December 2023 before the Annual Symposium.

This year, our team achieved remarkable milestones. We managed five conferences, a significant increase from only three in 2022, and actively participated in seven chapter events. We have decided to bring AOC Europe in-house starting in 2025, so 2024 will be our last year partnering with Clarion Events. At the Annual Symposium in December, we had a record number of attendees and exhibiting companies, marking an impressive 15% increase from 2022 and an outstanding 47% growth compared to 2021.

We spent much of the year working on moving to a new database and website, including chapter functionality, which will be implemented in March of 2024 – this will give us more information to serve our members better and will give our chapters greater insight to be able to focus on membership renewals.

Our five-year strategy focuses on building an Advocacy and Communications Enterprise. A vital element of this effort is our podcast, From the Crows' Nest, which continues to outperform other podcasts in our trade space. In 2024, we will launch members-only/subscriber episodes that provide better access for the audience. AOC members and podcast subscribers receive two additional monthly episodes and can participate in the live recording of these episodes.

The AOC Board of Directors and staff continue to evolve and execute our operating plan, strategy, and mission to support the association. We concluded 2023 in a strong, vibrant, and financially solid position, and 2024 will be an exciting and dynamic year.

# **FINANCIAL**

The Finance Committee held several meetings throughout the year to closely monitor the finances with a top priority of AOC's Five-Year Strategy.

#### AOC Current Obligations - \$392,475

Schwab (Fixed Income & Equities) - \$4,782,046; Checking - \$864,486

#### Available "Extra Funding" - \$2,427,057

Account Balances - (Reserve Fund + Operating Obligations) + Net Operating Income

AOC is financially solvent coming out of 2023 and has a stable foundation to start FY 2024.

## 2022 Financial Audit

The 2022 independent audit report showed a total loss for the year of \$654,229 (investment income and operation revenue from operation expenses) and that current financial operations reflect sound practices. The investment account correction was a loss of \$612,539 reducing revenue from \$3,421,712 to \$2,809,182.



## **Contractor Services**

#### Naylor Agreement

AOC has contracts with Naylor Association Solutions to produce the weekly electronic newsletter *eCrow* and the monthly publication, *Journal of Electromagnetic Dominance (JED)*, on our behalf. The contract for the *JED* expires 2024. We will be renewing the contract.

# **MEMBERSHIP**

Overall individual memberships show a slight increase and a 14% growth of industry membership compared to 2022 (see chart below). The Membership Committee consisted of chairman Jim Utt and Regional Directors Mark Schallheim, Amanda Brockermeyer, Erik Bamford, Jurgen Opfer, Karen Brigance, Dennis Monahan, Wayne Shaw, and Myles Murphy.

Individual dues are increasing from \$45 to \$75 in 2024; dues haven't seen an increase in more than 15 years. Current Industry Group Members will be converted to Partners with levels of Supporter (up to 10 individual seats); Advocator (up to 25 individual seats); Collaborator (over 25 individual seats). Additional seats can be purchased for a discounted price. Organizations not interested in the Partner Program (benefits for the company), can buy individual memberships in bulk in our group program. Organizations purchasing a group membership do not receive benefits at the company level.

# PROFESSIONAL DEVELOPMENT

The Professional Development program was temporarily halted for the majority of 2023 as we collaborated with McKinley Advisors to conduct a comprehensive evaluation of all AOC's educational offerings. This decision was prompted by the significant decline in participation in online and in-person courses and the "Certified Specialist in Electromagnetic Warfare" (CSEW) certificate program in 2022.

We will be implementing the findings of the comprehensive evaluation in 2024 including making webinars free for AOC members and charging non-members a small fee (\$25) and partnering with academic institutions for future delivery of the certificate program. Our goal is to maximize the delivery of valuable learning to members and customers while also increasing the bottom line for the association.

The primary source of professional development that AOC strives to offer its members is instructor-led professional development courses, hosted, and administered by AOC. These exist in the form of:

# ADVOCACY AND OUTREACH

Advocacy and Outreach continues to evolve based on the goals of AOC's five-year strategy, specifically building an advocacy and communications enterprise concept to deliver timely and professional resources and adapt messaging to a diverse and global stakeholder audience across military, government, and industry. This effort is central to AOC meeting growth expectations aligned with other strategic goals, including increasing and diversifying streams of revenue.

The main accomplishments for 2023 were the continued success of AOC's podcast, *From the Crows' Nest*, and continued influence on Capitol Hill. For AOC podcasts, listenership increased significantly, and revenue rebounded from 2022 as Naylor took over advertising sales and the show adopted a dynamic advertising model with a unique rapid-fire interview for the mid-roll advertisement. Naylor sold every month from May – Dec 2023, and has already sold out of advertising through all of 2024. Due to FTCN's growth, we are optimistic heading into 2024 to further increase revenue by adding additional episodes, including a subscription service as an AOC member benefit and special series covering specific topics, such as Test & Measurement.

On the downside, we had to delay new episodes of our sister podcast, the History of Crows, due to limited bandwidth. The establishment of the new AOC History Committee was designed to help, but we were only able to release one new *History of Crows* episode in 2023 telling the story of the founding of the AOC, released during AOC's 60th International Symposium and Convention in December 2023.

## 2023 Accomplishments/Activities

Advocacy and Outreach built on its reoriented program coming out of COVID from 2020-2021 and began aligning efforts to AOC's five-year strategy. For the program to be successful and to spur success across other departments, AOC must pursue an enterprise approach to advocacy that generates, packages, and distributes knowledge, relationships, and stakeholder value to growing and diverse audiences in the US and abroad. This effort will take several years to implement and fine-tune, but success will help accomplish AOC's strategic goals, including increasing and diversifying streams of revenue.


The main accomplishments were the continued success of AOC's two podcasts – *From the Crows' Nest* and the *History of Crows*. While listenership increased significantly, revenue dropped far below expectations. We had to change the advertising model away from the appearance of industry-sponsored episodes. This transition also led us to seek help from Naylor to help sell advertising. With the right pieces in place, we are optimistic about the revenue potential heading into 2023. Revenue generation aside, AOC podcasts proved to be an adaptable product that helps AOC connect with its diverse members around the world.


#### From the Crows' Nest (FTCN) Podcast

FTCN is a regularly scheduled podcast featuring interviews, analysis, and discussions covering leading issues of the day related to EW and EMSO. We produced 26 episodes of FTCN in 2023, and now have officially released 86 episodes (not including special conference and convention episodes) since May 2021. We will reach 100 episodes in Summer 2024. Episodes covering Ukraine, achieving Spectrum Superiority, AECA/ITA policy, the USAF 350th Spectrum Warfare Wing, JADC2, and Directed Energy were the top performing podcasts for the year. The podcast reached a new threshold of more than 100,000 downloads since its inception and regularly receives over 5,000 downloads per month. The FTCN audience reflects AOC's global membership – 72 percent US and 28 percent international – and receives downloads from 105 different countries. Most importantly, 73 percent of our listeners are under the age of 44 years old. More than a quarter (28 percent) are ages are 28-34 years old.

#### History of Crows (HOC) Podcast

History of Crows (HOC) Podcast HOC takes you on a journey throughout time and around the world to meet the inventors, the battles, and the technology that has not only shaped military operations - how we fight - but also how we live. HOC covers some of the most important discoveries, battles, and events that shaped what we know today as EMSO. Unfortunately, in 2023, we had to delay new episodes of the HOC podcast, due to limited bandwidth. The establishment of the new AOC History Committee was designed to help, but we were only able to release one new HOC episode in 2023 telling the story of the founding of the AOC. We are currently planning 4 new episodes in 2024, including episodes on the Wild Weasels, the ALQ-99, and the Falkland Islands.

#### **AOC History Committee**

In 2023, AOC established the new History Committee to steer the AOC History Initiative. The committee will oversee effort to capture, preserve and share the unique history of EW and EMSO to audiences around the world. The History Committee plans to provide peer review of the HOC podcast scripts, pursue museum partnerships, and identify other deliverables to better tell the AOC story to future generations. In 2023, the Committee began cataloging newly digitized files of recorded interviews and events. It also focused efforts on commemorating AOC's 60th anniversary throughout 2024.

#### Congressional Outreach

AOC has a consulting relationship with Forza DC, a small government affairs consulting firm to help rebuild AOC's congressional education program coming out of COVID. Throughout 2023, Forza DC was responsible for being AOC's primary interface with the congressional Electromagnetic Warfare Working Group (EWWG). Forza DC kept AOC abreast of developments in the annual defense budget process, as well as managed the transmission of hearing questions through the EWWG to the House Armed Services Committee.

In the Summer, Forza DC assisted in building an EWWG panel discussion co-hosted by the AOC and Hudson Institute. EWWG Co-Chairs and Representatives Rick Larsen, Don Bacon, and Chrissy Houlahan spoke to the live audience in attendance and online for about the evolving role of EMSO in INDOPACOM.

In the fall 2023, Forza helped the Advocacy and Outreach department with the strategy obtain AOC Board of Director approval to begin establishing a Political Action Committee in 2024. They helped develop messaging and FAQs and arrange interviews for potential PAC management consultants.

Finally, Forza worked with the Advocacy and Outreach Department to provide the EWWG revised EMSO language (Section 1682) in the FY 2014 National Defense Authorization Act, passed by Congress in December 2023 and signed into law by President Biden in January 2024.

Another initiative that was planned for 2023 but did not come to fruition was the re-establishment of the AOC Congressional Education Program. We had a series of briefings planned for Fall 2023, including EMSO in the Pacific, an update on the Ukraine War, and Spectrum Availability/Sharing. Unfortunately, due to a dynamic and uncertain congressional schedule due to delays in the budget process, as well as the removal of the Speaker of the House, we were unable to schedule any briefings. We are looking at Spring 2024 to reschedule.

#### Other Activity Highlights

In addition to the above deliverables, the Advocacy and Outreach department continued select initiatives from prior years, including:

- Increased stakeholder outreach (industry and military) through engagements in San Antonio, TX, and at numerous trade shows and conferences.
- Attended the Directed Energy Professional Society S&T Symposium in April 2023. Discussed future collaboration on an EMSO/DE workshop, possibly focusing on High Power Microwave (HPM).
- Began formal work on the CRADA with NSWC Crane to conduct a multi-year study on EW and Radar Technologies. Work on this study commenced in November 2023 with site visit to San Antonio, TX.
- Monitored Mark-Ups and Hearings in the House/Senate Armed Services Committees and provided analysis of FY 2024
  National Defense Authorization Act and available version of FY 2024 Defense Appropriations legislation, which has not been
  passed by Congress as of the end of the year.
- Conducted regular outreach to AOC Industry Members, including technical subject matter expertise and business development.
