- ii. The technology cited in the nomination must have operational relevance, and value to the warfighter or to those using it to improve the systems and weapons available to the warfighter.
 - 1. Describe the technology, why it is unique and its application in Electronic Warfare.
 - 2. Explain the operational relevance of this technology.
 - 3. Quantify the value of this technology to the warfighter.
 - 4. Describe what improvement made to EW systems and/or weapons.
 - 5. Explain how the improvement impacted the of survivability of the warfighter and/or equipment.

c.	EW Community Awareness:

i. Provide written details, specific examples and supporting information on how the nominee's contributions and achievements were evident to, and known by, the Electronic Warfare community.

ii.	Provide written details, specific examples and supporting information on how the nominee's contributions have clearly and continually contributed to significant technical advancement in EW over a long-term sustained period.
