- ii. Provide written details, specific examples and supporting information on the nominee made significant pioneer contributions to the discipline of Electronic Warfare. The nature of the contributions must have, in some way, materially improved Electronic Warfare.
 - 1. Describe the specific pioneer contributions being cited for this award.
 - 2. Explain the operational relevance of this pioneer contributions.
