Dr Robertson led the efforts on the Nominations and Elections committee to develop criteria and requirements of candidates for the Board and offices. She focused efforts on the election process and methodology. As a member of the AWARDS committee, she added necessary rigor to the principle annual awards for the AOC and helped to develop specific criteria. As an EW SME, Dr Roberston has also provided evidence to and testified to Parliament on EW issues related to the UK. She is also the author of the book *Practical ESM Analysis* Copyright: 2019. Without Dr Robertson's efforts, there would be no "International" in the AOC
