New Chapters

- International

- Spain – Approved before AOC Europe. Two officers with the Spain Chapter attended the Chapter Officers meeting at AOC Europe.

- US

- Minnesota – Approved – Have officers and are working on a logo (running a Logo contest) and the setup process.

Chapter Revitalization
